Beacon Light Behavioral Health Services Outpatient Clinic is a licensed mental health provider with traditional and school-based locations in McKean, Warren, and Forest counties.



BLBHS Outpatient Clinic has been awarded the designation as a Trauma Informed Care Center, for expertise in organizational trauma-informed practices, trauma specific modalities, trauma informed supervision, and complex program management.

Who can receive services?

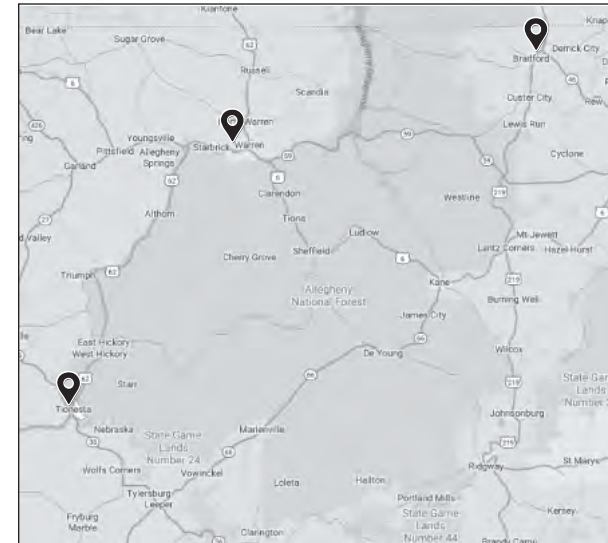
BLBHS provides comprehensive mental health services to adults, adolescents, children, and their families.

It is okay to ask for help.

Our goal is to prevent life stressors from escalating and to allow individuals to return to a healthier lifestyle.

Where are services offered?

Outpatient offices are located at 1885 Market Street in Warren, PA, 23 Kennedy Street in Bradford, PA, and 623 Elm Street in Tionesta, PA.



In the office setting, the following services are available:

- Psychiatric evaluation.
- Medication management & nursing services.
- Follow-up outpatient services for individuals recently discharged from inpatient hospitalization or residential treatment.
- Psychotherapy services (including individual therapy, group therapy, and family therapy).
- BrainsWay Deep Transcranial Magnetic Stimulation.

BLBHS also provides coordination with schools, other providers and specialists, and with families with the clients consent.

We also assist with referral coordination for other services.

Outpatient therapy services are also offered in the following school locations:

- East Forest School
- West Forest School
- Eisenhower Elementary & Middle-High School
- Warren High School
- Beaty-Warren Middle School
- Sheffield Elementary School

This allows for the therapist to meet with children and adolescents in the school location rather than requiring families travel to the office location for therapy services.
